One such benefit is with weight loss and body fat composition as suggested by a study done by the Yeterans General Hospital in Phyllagina, Talwan, Another study published by the Journal of Nutrition in 2007 suggested that CLA increased lean body mass in a 12-week study of overweight individuals.

LIPASE\* - Lipase is an enzyme that the body uses to break down fats so they can be absorbed in the intestines. Lipase is used in the body to increase absorbtion and improve digestion of fatty acids.
