

**Suggested usage:** PGX Daily® softgels can be taken with or without food with a glass of water (8–16 oz. or 1–2 cups) or as directed by a health professional.

**Week 1:** 1 softgel, 3 times daily.

**Week 2:** 2 softgels, 3 times daily.

**Week 3 and beyond:** 3 softgels, 3–4 times daily.
