If you weigh 120-200 lbs. (54-91 kg)

Take 1½ oz. (45 ml) = 1500 mg Glucosamine,
1200 mg Chondroitin, 750 mg MSM and 563 mg SierraSil

If you weigh more than 200 lbs. (91 kg)

Take 2 oz. (60 ml) = 2000 mg Glucosamine,
1600 mg Chondroitin, 1000 mg MSM and 750 mg SierraSil
