INDICATIONS AND USAGE: QufLora[®] Gummies is a dietary supplement indicated to provide essential vitamins and fluoride supplementation.

CONTRAINDICATIONS: QufLora[®] Gummies should not be used by patients with a known history of hypersensitivity to any of the listed ingredients.

PRECAUTIONS:

General: The suggested dose should not be exceeded, since dental fluorosis may result from continued ingestion of large amounts of fluoride. Do not eat or drink dairy products within one hour of fluoride administration. Incompatibility of fluoride with dairy foods has been reported due to formation of calcium fluoride which is poorly absorbed. Your healthcare practitioner can prescribe the correct dosage.

Folic Acid: Folic Acid alone is improper therapy in the treatment of pernicious anemia and other megaloblastic anemias where vitamin B12 is deficient. Folic acid in doses above 0.1 mg daily may obscure pernicious anemia in that hematologic remission can occur while neurological manifestations progress.

ADVERSE REACTIONS: Allergic rash and other idiosyncrasies have been rarely reported. Call your doctor for medical advice about side effects. You may report side effects or obtain product information by calling Carwin Pharmaceutical Associates, LLC at 1-844-700-5071.

WARNINGS: Keep out of the reach of children. In case of accidental overdose, seek professional emergency assistance or contact a Poison Control Center immediately. This product should be chewed and is not recommended for children under age 4.

DOSEAGE AND ADMINISTRATION: Take two (2) gummies daily, or as directed by a healthcare practitioner. Chew thoroughly before swallowing.

HOW SUPPLIED: QufLora[®] Gummies is available as an orange slice shaped gummy. Orange flavor. Available in a child-resistant bottle containing 60 gummies (15370-210-60) and in a professional sample (15370-210-02).

Store in a cool, dry place, tightly closed, Room temperature 15°-25°C (59°-77°F). Protect from light, moisture and heat.
