

FOR ADULTS, in the morning take 2 capsules before eating or exercising and in the mid-afternoon take 2 more capsules. Take 2 capsules twice daily. Do not exceed 2 capsules more often than four hours. Limit use to no more than 4 capsules in a 24-hour period. If you weigh less than 150 pounds, start with half the suggested amount for the first week (one capsule two times daily). Keep tightly closed.
