Directions for use: In the morning, 30 minutes before or two hours after your first meal of the day, take two Release capsules (from the blister pack). Also mix one rounded scoop (11.4 g) of Advanced Fiber Powder in an 8 fl oz glass of water, stir or shake briskly and drink immediately. At bedtime, consume the contents of one clear packet containing two HepatoCleanse capsules and two Release capsules.

Repeat this cycle for seven consecutive days, taking the fiber powder and capsules at the same time each day. NutriClean® Release promotes emptying of the bowels; individual response varies. Should you experience a strong laxative effect or cramping, reduce the number of NutriClean Release capsules* to one in the morning and one in the evening, and extend the Release portion of your cleanse over a longer period of time.

* The NutriClean Release capsules are the darkly pigmented capsules in the blister pack (taken in the morning) and the clear packet (taken in the evening).
