Follow by consuming another 8-16 ounces of liquid (water or juice). You may add the two liquid servings into one glass (serving) rather than two glasses (servings). Lots of fluids are important due to the drawing nature of this formula. If more powerful bowel moving action

is required, or you have a sluggish bowel, use with HealthForce Intestinal Movement Formula™. Can also be taken after a meal for indigestion symptoms.

INTENSIVE USE: 4-8 level tablespoons per serving.
