

DIRECTIONS FOR USE: Take two capsules of PHENBLUE® with 8oz of water 2 times daily, approximately 30 minutes before meals. This product is intended to be used along with a calorie-reduced diet and regular exercise program. Do not take within 5 hours of sleep.

MISSED DOSE: If you miss a dose, take the next as recommended. Do not double the next dose.
